Dear Sir,

This has reference to your recommendations for grant of autonomy to the following colleges mentioned in your letter no VC/STENO/07/382, dated 8.9.87.

1. Govt. Science College, Jabalpur.
2. Govt. M.H. College of Home Science for Women, Jabalpur.
3. Govt. Mahakoshal Arts & Commerce College, Jabalpur.

These recommendations have been concurred to by the Madhya Pradesh State Government vide letter No. F.73/32/86/C-3/80 dated 16.6.88 from Shri S.C. Joshi, O.S.D., Higher Education Deptt. Govt. of Madhya Pradesh, Bhopal.

I am now pleased to convey concurrence of the UGC to the grant of autonomous status to the aforesaid colleges by the University. This is subject to the following:

1. The Colleges shall constitute organisational structure on the lines suggested in the UGC revised guidelines (1986) on the scheme of autonomous colleges, which may be agreed to by the University.
2. The autonomous status may be granted by the University for a period of five years in the first instance and review shall be undertaken by the University after three years as to the performance/functioning of the colleges with the help of the Committee as indicated in the UGC guidelines; and
3. The Colleges shall start functioning as 'autonomous' from the commencement of the academic session 1988-89.

Necessary orders granting autonomous status to the colleges be issued by the University under intimation to the Commission. The University may also ensure that the colleges constitute the required committees as per the UGC Guidelines.


The UGC assistance to the Colleges will be available on receipt of information from the University that the colleges have adopted organisational structure and started functioning as autonomous colleges, in accordance with the guidelines.

As you may be aware that the UGC has a scheme for Autonomous Colleges, which provides for academic autonomy to a college to achieve excellence in higher education system. Under this scheme the Autonomous status to a college is granted based on the "No Objection" given by the affiliating University with the concurrence of the respective State Government and subsequent approval of the UGC, initially for a period of six years.

The UGC has received a proposal of Govt. Science College, Jabalpur (MP) affiliated to Rani Durgavati Vishwavidyalaya, Saraswati Vihar, Pachpedi, Jabalpur-482001 To evaluate the performance and academic attainments for the Extension of Autonomous Status, the Chairman, UGC has constituted an expert committee. The autonomy review of our college for the above period is awaited since long time.
